ISC 2020-2021 Ice Report

The total ice bill for the 2020-2021 season was \$27,823.28 + HST = \$31,440.31. The hourly ice cost was \$125.66 + HST = \$142.00 (same as last season). Ice was generally used on Wednesdays from 4pm to 9pm, Saturdays from 11am to 4pm, and Sundays from 1pm to 5:30pm, except for miscellaneous holidays. In addition, ice on Wednesdays was used from 4:45pm to 9pm in September and on Sundays from 1:00pm to 3:40pm in March.

The start of the 2020-2021 season was delayed to the end of September and ice was not available in January and February 2021 because of COVID-19, resulting in a reduction in ice costs of \$12,081.54 (inclusive of HST) from the 2019-2020 season.

As you can see, I am unable to provide a clear amount with regards to our chocolate bar monies. The goal next seasoning is to have a more precise way of calculating, with a spreadsheet containing when the chocolate bars were signed out, how many each family sold, and the date of return of the funds. As noted, restrictions were placed on the arena that did not allow chocolate bars to be brought into the facility, nor the handling of paper. We are hopeful restrictions will be lifted thus allowing us to obtain a more diligent way of accurately recording the sales.

Registration

Due to the pandemic, registration did not open until late August this year. Once again, registration was completely done online.

The pandemic added many complications to our programs this year...

- COVID Mandatory Screening
- Increased rules and protocol at the arena
- The inability of coaches and PAs to physically assist the skaters
- Multiple lockdowns
- Multiple changes to government implemented rules and regulations, to name a few.

Through all these changes and added protocol, our skaters, parents, coaches and board members worked through it all wonderfully and made this year a successful one in spite of all the challenges.

A special thank you to our amazing coaches who repeatedly altered the schedules as new government mandates were released including, at times, making multiple versions to cover all possibilities. It was an exhausting year but through it all they continued to coach the skaters with the same positivity and enthusiasm they always have.

With the requirements passed down from Skate Ontario, we were not able to offer hour CanSkate Pre-Beginner this year. As an alternative, we offered additional Parent & Tot sessions which allowed parent to assist their children on the ice when our coaches and PAs could not.

Program Assistants

It has been a challenge to navigate the ever-changing rules and regulations stemming from the pandemic. Social distancing regulations dictated how many people could be on the ice, which meant that the casual 'drop-in' basis on which our PAs have volunteered their time in the past just wouldn't work anymore. To ensure we did not exceed maximums, I implemented a PA schedule, which had the added benefit of ensuring our coaches and skaters had ample support in each of our CanSkate, Learn to Skate, Parent & Tot, and Junior sessions. I'm proud to say that we managed better coverage with significantly fewer PAs than last year. The feedback has been overwhelmingly positive and I recommend that we continue scheduling shifts for the PAs in coming years.

In addition to shift scheduling, I was asked to implement a way for PAs to log their own hours on an app. Clockify was chosen for its straightforward interface and the limited personal information it required for each user's account setup. Usage was relatively good, with nearly 75% of PAs logging their hours regularly. As an administrator, the free version of the app was sufficient for our needs. In the future, however, I propose that the app is redundant if there is still going to be a schedule set. If coaches get a master schedule, it would take only seconds to cross off anyone who missed their shift. The PA Coordinator could then keep a running total.

Our team of Program Assistants comprises 11 skaters, aged 10 to 16. Each one of you deserves recognition for showing up for the Club this year. On behalf of the Board Members, Coaches, Parents, and skaters, thank you Emily, Olivia, Breanna, Austin, Cierra, Wynn, Sukhmeet, Ayla, Abby, Matayah, and Jadelynn. While you couldn't actually hold their little hands this time around, your encouragement and positivity helped hold them up nonetheless.
